ELDER RESPONSE INITIATIVE



For The Struggle's Eco-Senior Program reduces energy costs for seniors on fixed incomes while simultaneously addressing environmental injustices in historically and predominantly black communities. In doing so the Eco-Senior Program offers the following services: Weatherization, installation of low-flow water fixtures, led lighting, appliance upgrades, installation of smart thermostats and more.

THE PROCESS:

Step 1: Submit Your Application

To be eligible for FTS's Eco-Senior Program you must submit a completed application along with supporting documents for pre-approval. Supporting documents include:

- Proof of income for all household residents 18+ (Two months of recent paystubs or current year's SSI benefits letter and/or retirement benefits letter)
- Two months of your most recent bank statements
- Current Homeowner's Declarations Page
- Current mortgage statement (if applicable)
- Signed declaration that you will continue to live in the home for a minimum of five (5) years.
- Signed declaration that you will provide monthly utility bills 12 months after becoming a FTS Eco-Senior.

- Last three months of utility bills (electric, gas and water)
- Annual income of \$41,300 or less

An FTS intake specialist will help you through the process of preparing your application and supporting documents and will submit the application on your behalf and work with you throughout the process. For more information, please call 704-800-6628.

Step 2. Application Assessment

Once your application and supporting documents are received, your application will be assessed to ensure your household meets all criteria necessary for your participation in FTS's Eco-Senior Program. If all criteria are met then you are considered pre-approved.

Step 3. Home Visit

An FTS representative will conduct a home visit to assess your needs and to discuss the details of the program, expectations, and answer any questions or concerns. At this meeting, you will also sign a release and waiver form and any additional contracts or forms required. You will also receive a tentative timeline regarding upgrades.

Step 4. Upgrades

Upon FTS's approval of the costs to perform upgrades at your home, such work will be scheduled to begin.

Step 5. Follow Up Visit

A FTS Representative will do a follow up visit to discuss your upgrades and to obtain a statement from you regarding the upgrades and how they have helped your use and enjoyment of your home.

Step 6. 12-Month Testation Period

To be eligible for this program, you are required to submit a copy of your utility bills for 12 months after your upgrades are complete. This required documentation will serve as data for FTS to assess as we work towards our mission to not only create environmentally friendly homes, but address environmental injustices in historically and predominantly black communities and reduce utility bills for seniors in our network.
